CHEMICAL DESCRIPTION

PLIOGUM® 6643A is a Kosher and halal high bound styrene polymer manufactured by the hot polymerization of butadiene and styrene in accordance with good manufacturing practices as defined by Goodyear Houston's current GMP manual. PLIOGUM® 6643A meets all applicable requirements of the U.S. Food and Drug Administration, the Food Chemicals Codex, and the specifications for chewing gum base components established in Italy, France, Germany and Spain.

APPLICATIONS

PLIOGUM® 6643A is widely used in chewing gum base and bubble gum base applications when BHA is the required antioxidant. It is most suitable for gum with a firmer chew, as well as for bubble gum where large bubble size and stability are highly desirable.

It is also used in other food contact applications, such as food can sealant. It is a highly branched polymer capable of handling high filler loading.
