CHEMICAL DESCRIPTION

PLIOGUM® 1027K1 is a ground crumb version of PLIOGUM® 1027, a food grade Kosher and Halal copolymer manufactured in accordance with Good Manufacturing Practices by subjecting PLIOGUM® 1027 to grinding through a 5/8" screen, then blended with high purity, ultrafine talc, food grade, as a partitioning agent. PLIOGUM 1027K1 meets all applicable requirements of the U.S. Food and Drug Administration, the Food Chemicals Codex, and regulations governing chewing gum base components established in Italy, France, Germany, Spain, and other countries.

All specification limits except for the partitioning agent content apply to the base polymer before grinding.

APPLICATIONS

PLIOGUM® 1027K1 is widely used in chewing gum base and bubble gum base applications. It is most suitable for chewing gum with a regular or soft chew.

It is also used in other food contact applications, such as food can sealant. It is a highly branched polymer capable of handling high filler loading.
